

PERCENT OF FISCAL YEAR 2003 ALLOCATION USED, BY PROCESSOR
REVISED MARCH 23, 2004

The following updates the summary of utilization of each processor's total and final allocation of the 2002 crop. In the cane sector, 45,000 tons of allocation was not used. Meanwhile, 19,000 tons were blocked from sale. The beet sector summary was unchanged from the previous display. In aggregate, the cane sector used 99.4 percent of its total allotment, while the beet sector used 99.2 percent of its allotment.
