

# USDA AMS NATIONAL ORGANIC PROGRAM COST-SHARE PROGRAMS 2012 REPORT TO CONGRESS

## A. BACKGROUND

The U.S. Department of Agriculture's (USDA) Agricultural Marketing Service (AMS) National Organic Program (NOP) administers two organic certification cost-share programs. Each program provides cost-share assistance, through participating States, to organic producers and/or organic handlers. Recipients must receive initial certification or continuation of certification to the NOP regulations from a USDA-accredited certifying agent. Reimbursement is currently available at 75 percent of an operation's certification costs, up to a maximum of \$750 per year.

The first program is the Agricultural Management Assistance (AMA) Organic Certification Cost-Share Program, which was established in 2001 as part of the Agricultural Management Assistance Program. This program is authorized under Section 1524 of the Federal Crop Insurance Act (FCIA), as amended, (7 U.S.C. 1501-1524). It authorizes cost-share assistance to producers of organic agricultural products in Connecticut, Delaware, Hawaii, Maine, Maryland, Massachusetts, Nevada, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Utah, Vermont, West Virginia, and Wyoming. The AMS received \$1.5 million for the fiscal year (FY) 2012 AMA program.

The second program is the National Organic Certification Cost-Share Program, which was re-established as a part of the Food, Conservation and Energy Act of 2008 (7 U.S.C. 6523). This program was initially established as a part of the Farm Security and Rural Investment Act of 2002 (7 U.S.C. 3007). It authorizes cost-share assistance to producers and handlers of organic agricultural products in all States and U.S. Territories (hereafter known as "States"). In FY 2008, Congress provided on a one-time basis \$22 million for this program, to be allocated to States until the funds are exhausted. To prevent duplicate assistance payments, producers participating in the AMA program are not eligible to participate in the producer portion of the National program.

AMS invited State agencies to participate through Federal Register Notices, press releases, Grants.gov postings, electronic communications and personal phone calls. On September 6, 2011, a Notice of Fund Availability was published for both programs in the Federal Register (76 FR 54999-55000). Both notices and their accompanying press releases were posted on the NOP website. The funding opportunities were also posted on Grants.Gov on August 1, 2011.

## B. FY 2012 PARTICIPATION AND FUNDING OBLIGATIONS

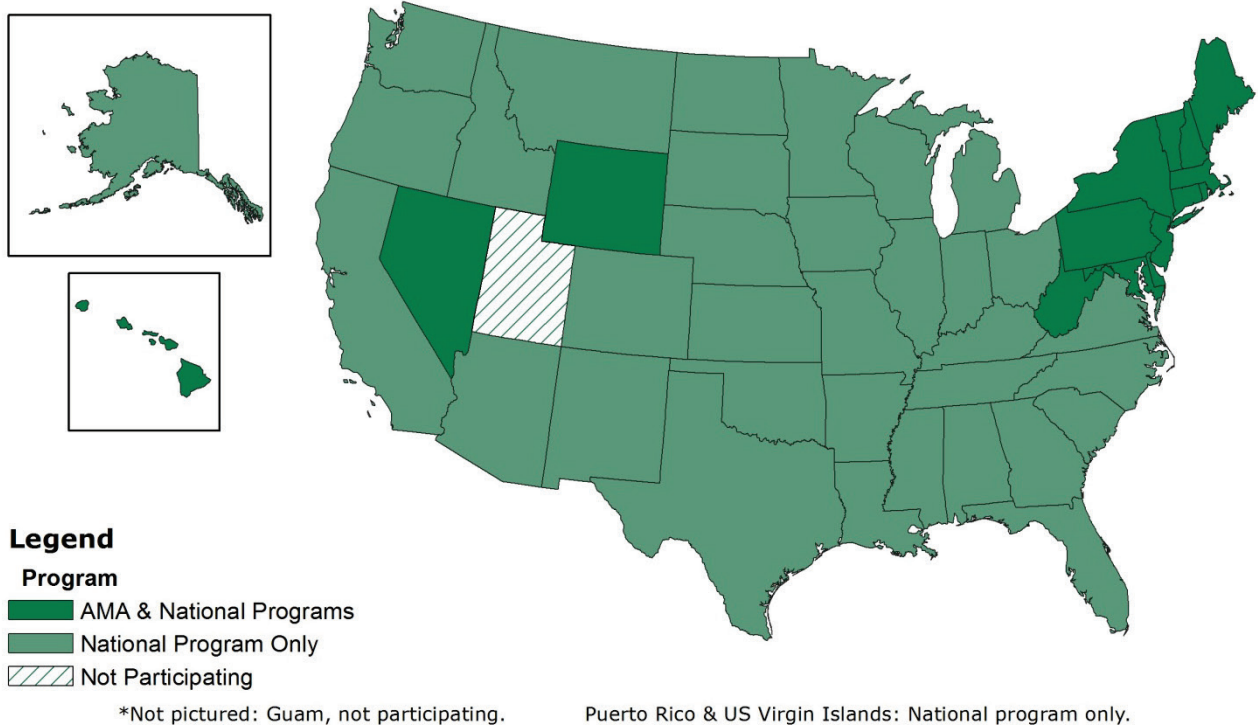
Forty-nine states, the Commonwealth of Puerto Rico, and the US Virgin Islands are all enrolled in at least one of the cost-share programs for FY 2012, as shown in the map below. Detailed enrollment and allocation data are outlined in [Table 1](#) in the appendix.

- Application instructions and cooperative agreements for the FY 2012 were sent to the 16 AMA program eligible States. All but Utah are participating in the program. The Utah

Department of Agriculture and Food chose not to submit an application to participate in either cost-share program, citing inadequate staff resources to manage it.

- Application instructions and cooperative agreements for the FY 2012 National program were sent to the 50 States, U.S. Virgin Islands, Guam, and Puerto Rico. All but Guam and Utah are participating in the program.

## STATE PARTICIPATION: FY 2012 ORGANIC CERTIFICATION COST SHARE PROGRAMS



- For the FY 2012 AMA program, \$1.5 million will be allotted for cost-share assistance.
- For the FY 2012 National program, \$5.747 million has been allotted to the participating States for the period October 1, 2011, through September 30, 2012.<sup>1</sup>
- Total program funds allotted in FY 2012 for both cost-share programs are \$7.247 million.
- To receive funds, State agencies are required to submit requests for disbursements. As of January 31, 2012, \$6,104,376 has been disbursed to State agencies. Fund requests are typically more frequent in the third and fourth fiscal quarters. In FY 2011, about two-thirds of fund requests were received in the last half of the fiscal year.

## C. SUMMARY OF FY 2011 AGRICULTURAL MANAGEMENT ASSISTANCE COST SHARE PROGRAMS FUND USE

- Results shown in [Table 2](#) are cumulative data of FY 2011 cost-share assistance payments provided to AMA-eligible organic operations certified between October 1, 2010 and September 30, 2011.
- \$1.495 million in annual funds were allotted through cooperative agreements to the 15 of 16 eligible States for the AMA program in FY 2011.
- As of January 31, 2012, AMA program States provided \$1,151,327 in cost-share assistance to 1,861 organic producers, an average payment of \$619.
- 6 States provided more funds in cost-share assistance during FY 2011 than FY 2010, and 6 states provided funding at approximately the same level. Utah did not participate in the FY 2011 AMA program.

## D. SUMMARY OF NATIONAL PROGRAM FUND USE IN FY 2011

- Results shown in [Table 3](#) are cumulative data of FY 2011 cost-share assistance payments provided to organic operations certified between October 1, 2010 and September 30, 2011.
- In FY 2011, \$5,527,500<sup>2</sup> was allotted through cooperative agreements to the participating States.
- As of January 31, 2012, National program States provided \$4,953,049 in cost-share assistance to 7,482 organic producers or handlers, an average payment of \$662. Final reports are pending from two States, Pennsylvania and the U.S. Virgin Islands.
- Unused funds or funds returned by States will be reallocated to States through new cooperative agreements. 9 States have requested fund increases since September 2011.
- 37 States provided more funds in cost-share assistance during FY 2011 than FY 2010, and 8 States provided funding at approximately the same level. One State and three territories did not issue any reimbursements in the FY 2011 National program: Guam, Puerto Rico, Utah, and the U.S. Virgin Islands.

## E. OUTREACH AND TECHNICAL ASSISTANCE

The NOP conducted a publicity campaign during FY 2011 to promote the cost-share program.

- Staff made presentations on the cost-share program at 6 national conferences.
- Staff visited 6 state government offices to conduct surveillance activities.
- Advertisements ran in 12 organic, farmer's market, and small farm trade publications.
- Over 16,000 certified organic operations received postcards announcing the program.
- Approximately 3,500 email subscribers received one or more emails about the program.
- Nearly 5,000 brochures on the program were distributed nationwide. FY 2012 brochures are also available in Spanish.
